**Motion to approve by Trustee Horne with the exception of Al G. Ronan and Seconded by Trustee Jones**

Discussion: Trustee Senior read the Warrant list. Miller clarified that Trustee Horne wants to hold Al G. Warrens invoice and pay all others. Mentioned that we should've asked for detailed information regarding his invoices and that we are probably not legally able to withhold payment. Also requested information from the Finance department on the Riley construction payments to be sent at a later time. Trustee Jones elaborated on Ronan's contract. Also directed question to Budget Officer regarding payments to Herritage, also questioned payments to Markham Real Estate (Dunkin Donuts). Tom Hood responded. Trustee Horne elaborated on her position regarding Al Ronan's invoice. Still questions which legislation directly impacts Broadview and how do we define success. Is still prepared to delay payment and is considering not renewing contract if we don't receive more detailed information. Also questioned Chase credit card invoice. Tom Hood responded.

**Motion Fails: 2-3**

**A motion to reconsider by Trustee Tierney to pay all bills as presented and seconded by Trustee Miller**

Discussion: Trustee Miller understands what Trustee Horne is requesting; however, this specific information being requested is not a part of the contract. Please remember this before the Board put's itself in a legal predicament. Trustee Jones disagrees and states that another vote will end in a 3-2 vote and nobody gets paid. Again, states Ronan's invoice is a general statement that defines things that are going on downstate and nothing specific to Broadview. Trustee Senior believes we should move forward and pay the bills. Chairman Tierney asks for the atty to weigh in. Atty Jaworski speaks about the Illinois local government prompt payment act specifying requirements to pay bills within 30 days of being received. She suggests that bills be paid and possibly sending Ronan a letter if they are concerned about how he performs his services. Atty. reminds the board that 1% interests can be added by this contractor and others who choose to do so. Chairman Tierney reminds the Board that they have been paying Ronan's bills as presented for over a year now, why stop now. If the Board were going to question it, why not sooner. Suggests a letter to Ronan asking for further clarification. Trustee Horne states that the bills were submitted late, dating back from June 2019 and we are just receiving them. Atty Jaworski again recommends that the bills are paid as presented and following up with a letter requesting more detailed information be provided with Ronan's future invoices. Chairman calls for roll call and Trustee Jones insisted on follow up. Trustee Jones speaks about not having received the invoices prior to 2 weeks ago. Also speaks about the contract specifics. Trustee Jones mentioned that Ronan came in with our current attys and has a relationship with them. Atty Jaworski comments that although their firm has relationships with many people just as everyone else here does and this information is completely irrelevant. Atty again reminds the Board that per the Illinois local government prompt payment act that the bills are to be paid within 30 days of receipt. Chairman Tierney further stated that both Trustees that voted against paying Ronan's current invoices have voted to pay them in the past. Trustee Horne states she doesn't want the Village to incur additional expenses and is debating on paying bills as presented or not.
