# Seasons Greetings!

I want to begin by wishing every resident of Broadview a happy, healthy and peaceful holiday season. This is a time for family, community and rest after a long and fruitful year. In the season's spirit of peace and cooperation, I am proud to say that the Village of Broadview is working together like never before to deliver effective services and build a vibrant community.

In 2010, the Chicago water rates were projected to increase by a modest amount. However, in 2011 the new Chicago administration announced a 4-year rate increase ( 25%, 15%, 15% and 15%) starting in January 2012. This high rate increase was justified by Chicago to pay for its aging infrastructure, which supplies water to the City and Suburbs. The Broadview Westchester Water

Agency (BWWA) purchases water from Chicago and sell it to the Villages of Broadview and Westchester. BWWA also increased its water rates to adjust for the Chicago increase as well as increases in its own expenditures. Over the 4 years of increase, the Village did not raise its water rates to keep up with the increases. The difference was paid from the Village's Water Funds healthy reserve that we created.

During the 2019 water rate study it was determined that the Village's water rates should increase by \$0.30 rate increase that will be effective to all customers on January 1, 2020. After each budget year thereafter, there will be a percentage increase of 10.47% effective May 1, 2020; 9.48%, 2021, 8.66% 2022 and 7.97% in 2023. These increases would help rebuild the Water Funds reserve to meet the future capital project needs. In 2019 capital projects included the system wide water meter and meter radio replacement (Smart Meters). At their November 18th meeting, the Village Board approved the increases in the water rates.

As we are quickly approaching the Christmas season, I would like to ask everyone to please check out our local stores for gifts and other purchases first. It is critical to support our local merchants all year long, but especially at this time of the year. Many of us will be buried in advertisements trying to sell us stuff with a click of the computer mouse, a phone call or a trip to the mall. They make it sound so easy, but dollars spent out of town never return where dollars spent locally are spent over and over. There are many choices when it comes to shopping, but no one will appreciate your business more than our local merchants. I

am very sure that you will be impressed with the merchandise selection, the friendly smiles, and maybe even free gift wrap. The more purchases that are done in town, the more our businesses will be able to support the community. I suspect they contribute far more to our local economy, churches, or school fundraisers than an online retailer or a mall store. I am not suggesting that you should exclusively purchase locally, just that you start your search here for the "perfect" gift. I would also like to take this opportunity to wish you all happiness and success in the coming year. While 2019 gave us a great deal to celebrate and be thankful for, 2020 can be even better!

#### WHEN WILL I COMPLETE THE CENSUS?

The next census will take place in 2020. Beginning in mid-March, people will receive a notice in the mail to complete the 2020 Census. Once you receive it, you can respond online. In May, the U.S. Census Bureau will begin following up in person with households that haven't responded to the census.

#### **HOW CAN I RESPOND?**

In 2020, for the first time ever, the U.S. Census Bureau will accept responses online, but you can still respond by phone or mail if you prefer. Responding should take less time than it takes to finish your morning coffee.


#### WHAT INFORMATION WILL BE REQUESTED?

# **Public Works Director** | Matthew Ames

Winter is upon us and gives us all an opportunity to enjoy the great outdoors. There are a few things we should look at to ensure that there are no unwanted surprises in the Spring. Gutters and downspouts should be inspected to insure that periods of snow melt don't cause ice-damming along gutter lines. Similarly, are drains and sump discharges should be cleared. Now is a good time to make sure furnaces, including filters, are serviced. Chimneys of active fireplaces should also be inspected. The biggest concern for Public Works will be snow and ice control; here are some not on how not to go about it:

- In order to keep the street safe, the Village Ordinance prohibits street parking during the snow season, or after a two-inch snowfall, until after the streets have been cleared by Village plows.
- The Village recommends waiting to remove snow from the driveway apron until the roads have been plowed from curb to curb. Please do not push snow from driveways out into the street as this can cause hazardous driving conditions.
- The Public Works Department is often able to clear the sidewalks of snow using our trackless vehicle. If your sidewalk is cleared by the trackless residents can help by salting the sidewalks.
- Refuse collection can be more difficult during the winter months when there is snow on the ground. The village respectfully requests that all



- refuse and recycling containers be placed on parkway adjacent to the street. Please do not put containers in the street as this can create a hazard for drivers and makes snow plowing less efficient.
- Please look out for neighbors who may need help with snow removal and help if possible.
- Please DO NOT PASS SNOW REMOVAL EQUIPMENT as they can't always see you.

#### **Tips Before winter:**

- Be sure to remove all hoses from outside spigots and turn off the valve that feeds the spigot, if possible. Once this is done, open the spigot to release any leftover water, which prevents freezing and cracking.
- If your water meter is in an uninsulated area, please keep the door open to allow heat to access the space. The warm air will help to avoid frozen water lines and bursting pipes!



# **Finance Department**

As the calendar year prepares to come to close the Finance Department is working extremely hard on several initiatives. First, we are working to complete the Financial, Other Post-Employment Benefit (OPEB) and Fire & Pension Audits. Secondly, the Finance Team has worked with the Mayor, the Village Administrator, the Public Works Department and others to present a sound fiscal strategy to bring the Village's Water Rates in line with other Villages in the Proviso Township. As a result, the increases that will take effect over a 5 Year period the Village will be a position to apply for a low interest rate revolving loan from the Illinois Environmental Protection Agency (IEPA) to replace the aging water infrastructure. The Water Fund will be the source of the loan repayment therefore it's necessary to discontinue the deep subsidies that the Village has been providing the residents and businesses because the significant water rates increases from the City of Chicago were never passed along to the customers of the Village. The Mayor and the Finance Department including the Village Administrator met with the key commercial and industrial businesses in the Village to ensure that their concerns were heard and addressed. Additionally, during the several Finance Committee Meetings the potential water rate increases was presented to the residents of the Village. As a result, the Village introduced a \$0.30 rate increase that will be effective to all customers on January 1, 2020. After each year thereafter, there will be a percentage increase of 10.47% in Year 2, 9.48% in Year 3, 8.66% in Year 4 and 7.97% in Year 5. The Village will also introduce 3-tiered pricing to provide volume discounts for high volume customers. Lastly, we look to continue making improvements to be more efficient and effective the Finance team has been evaluating the banking relationships on the Village to ensure that we are being offered the best services and the best prices.









The monthly (YELLOW) water bill is mailed out on the 15th of the month.

Water bills are due by the last business day of the month.



The penalty (PINK) water bill is mailed after the monthly bill due date. A 10% penalty fee is added to the second notice once the bill is late.



Water meters are read each month by the Public Works Department. A monthly (yellow) water bill is mailed on the 15th of the month. The due date is noted on the left side of the yellow bill where it is stated "PAY BY" and the date/time it is

#### **Shut Offs Process**

After the penalty due date, the shut off process begins. There is \$10.00 Administrative fee added to the account once water has been shut off. When the water has been shut off, there is a \$50.00 restore fee added to the account. In order to have the water restored, the past due payment plus a \$10.00 Administrative fee, plus the \$50.00 restore fee. Water will be restored 24 hours after payment has been credited to the account.



# **Holiday Safety**

Just a few things to remember as we get closer to the holidays:

- Be sure to schedule package deliveries for a time when someone will be home. Thieves have been known to follow UPS or FedEx truck around, looking for opportunities to steal.
- Women If you carry a purse, never leave it in a shopping cart while you're shopping. Thieves know your attention is on the merchandise, and they can easily walk away with your personal items.
- Note the 1-800 number on the back of your credit cards, so that if you lose one or if it is stolen, you can quickly call the bank to have the card canceled.
- Place your new purchases in the trunk of your car while you shop, so that thieves won't be tempted to break a window and make off with your gifts.
- If you have boxes from expensive electronics after Christmas, don't leave those boxes by the curb on garbage day. Doing so advertises to criminals what's inside of your home.

# Warming up Your Car for THIEVES

For this reason, it's actually illegal to leave a car running and unattended.

And remember also that 95% of our vehicle burglaries occur to vehicles that were left unlocked by the owner. Don't think your car is safe just because it's in your driveway or because items of value are out of sight in your glove compartment; if your doors are unlocked, that's the first place a thief will look. This winter, let's be safe. Lock those doors!

# **Senior Housing Update**

Earlier this year, the Illinois Housing Development Authority(IHDA) Board passed Resolution 2019-IH-DA-09H which authorized the 1,500,000 tax credits for the Village of Broadview's Senior Housing Project. The tax credits could possibly yield \$13,000,000.00 - \$14,000,000.00 in financing. Currently, the Village of Broadview is working with WORN JERABEK WILTSE AR-CHITECTS on the design/layout, environmental studies, village codes, and contractors for the senior housing project. The Village anticipates breaking ground in the summer of 2020.

On August 14, 2019, the Illinois Association of Enterprise Zones approved our enterprise zone application. # **Heating System Checklist**

Fall is the time to prepare for winter. As you prepare for this winter, make sure that you winterize your heating system:

- Test run: Turn the thermostat to heat mode and set it to 80 degrees, just for testing. You should hear the furnace turn
  - on, and warm air should begin to blow within a few minutes. If the furnace is running fine, turn the thermostat back to its normal setting. If the furnace is not running properly, call a qualified service technician to service your furnace.
- Replace the air filter: Put in a new clean air filter. It is easy, and doing so will ensure a free flow of air and a cleaner environment. Each furnace has its own requirements for air filters, so follow the manufacturer's recommendations.
- Check fuel supply: If you have a propane or fuel oil furnace, make sure that your fuel storage tank is topped off and ready to go.
- Inspect and clean heating vents: Clear obstacles to heating vents, so air can freely flow. Many experts recommend having a service technician come in and clean the vents every year or two.
- Check for carbon monoxide leaks: This silent killer can be detected with either an inexpensive test badge or battery-operated alarm. If you discover problems, call in a professional immediately to identify and correct the cause of the CO leak. Usually, this involves leakage in the exhaust system of a furnace or other fuelburning appliance, such as a water heater. A CO leak is a very dangerous situation.
- Check exhaust vents: Some furnaces and boilers, as well as gas water heaters, vent through a chimney, while newer high-efficiency models may vent through plastic pipes running through a side wall. Make sure these vents are open and free of obstructions. A vent that has not been used all summer may have become home to birds or other animals, which can block the vent pipes and interfere with the furnace's ability to burn efficiently and properly vent exhaust gases.

# **Ordinance News Updates**

Please refer to the Village of Broadview Building Code (www/broadview-il.gov) for information regarding:

#### OCCUPANCY 10-7-2: CERTIFICATES OF OCCUPANCY:

#### A. Certificates Required:

- . No land shall be occupied or used and no building or structure hereafter erected or altered shall be occupied or used in whole or in part for any purpose whatsoever until a certificate of occupancy shall have been issued by the building commissioner and, except for dwellings, posted on the premises stating that the intended use of land and building complies with all the building and zoning ordinances of the village and with the provisions of these regulations.
- 2. A new certificate of occupancy is required if the occupancy, ownership or use of any building, structure or land is changed, or if alterations are made to any building, structure or land or part thereof. A new certificate voids any certificate of prior date. The requirement of a new certificate of occupancy for all transfers of ownership of real estate in the village shall be reflected on all real estate title insurance reports conducted precedent to the transfer of ownership to give public notice of said mandatory certification.

#### B. Application and Issuance of Certificate:

Change Of Occupancy, Ownership Or Use:
 Written application shall be made for a certificate
 of occupancy by the owner or duly authorized
 agent for the owner of any building, structure
 or land, prior to any change of occupancy,
 ownership or use. Written application shall also
 be made for a certificate of occupancy by the
 new occupant of a commercial or industrial
 building or structure prior to occupancy. Said
 certificate shall be issued within ten (10) days
 after written application therefor; provided, the
 building or structure shall be entitled thereto, or
 the building commissioner shall state in writing
 the reasons for his refusal to issue said certificate.

# If a business license is required, the certificate of occupancy shall be issued in conjunction with the business license.

2. New Buildings And Alterations: Written application shall be made for a certificate of occupancy coincidental to the application for a building permit. A certificate of occupancy shall be issued within ten (10) days after the erection or alteration of such building has been completed provided, the building or alteration shall be entitled thereto, or the building commissioner shall state in writing the reasons for his refusal to issue said certificate.

3. Inspections: Before any certificate of occupancy shall be issued, the building commissioner shall order a thorough inspection by all applicable inspectors and inspection branches of the building department, and no certificate of occupancy shall be issued unless the building or structure shall comply with all provisions of this title and amendments thereto and the building commissioner shall have signed approval from all applicable inspectors and inspection branches.

#### **GARBAGE COLLECTION**

#### 4-5-3: COLLECTION BY VILLAGE; RESIDENTIAL UNITS:

#### A. Residential Units:

- Solid Waste Containers: Residential units shall be responsible to utilize village approved sixty five (65) gallon solid waste containers for the disposal of municipal waste within the village.
- Additional Waste: If the residential unit has additional waste, which exceeds the maximum capacity of the sixty five (65) gallon solid waste container, they may place their own thirty five (35) gallon containers out for collection provided that the residential unit attaches an additional solid waste sticker to said garbage receptacle.
- Placement Of Containers: Residential unit garbage and trash containers shall be placed at the edge of the alley or on the parkway between the hours of six o'clock (6:00) P.M. of the day preceding collection until seven o'clock (7:00) P.M. of the day of collection.
- 10. Location Of Containers: All containers for garbage, ashes and household rubbish shall be stored outside the residence or other building in an accessible place and at ground level on the owner's private property. No container used for the storage, collection and removal of garbage or other refuse shall be placed in a thoroughfare or in a manner which constitutes a nuisance to adjacent property or the occupants thereof or to the public in general. 
