Dear Neighbor,

Residents are out walking, biking, and picnicking. Neighbors are swapping stories over their fences. Children are playing in their yards. Gardens are blooming. Summer has arrived in Broadview.

If we are on the cusp of summer, that means the Village of Broadview has already adopted its new budget,

which runs from May 1, 2022 to April 30, 2023.

The Village Board of Trustees approved the Fiscal Year Annual Budget on April 28, 2022. The new budget is a fiscally responsible plan that will enable the Village to provide the community with high quality municipal services, such as police and fire protection, reliable and clean water, as well host community events, such as Juneteenth.

Still, Broadview faces financial challenges, including: stabilizing the sales tax base over the long-term, increasing pension obligations, rising health care costs, funding for vehicles, equipment, and building capital improvements. The Village Board and I remain committed to conservative spending while continuing to invest in our community and providing superior services to our residents.

For example, Broadview's investments this year will include the following:

- Over \$469K in (20th, 21st and 22nd between Roosevelt and Fillmore)
- Over \$4.3M in water main improvements and alleys from 17th to 25th Avenue in the commercial district
- Over \$334K in street repairs 16th Street Paving Improvements

These investments in Broadview's infrastructure will enhance the quality of life for all residents and meet the needs of our local businesses.

Still, a community's quality of life cannot be measured by cement, bricks, and asphalt alone. A community must also invest in culture as well as concrete.

Broadview's cultural investment includes, for example, hosting our now annual Juneteenth celebration. The celebration kicked off on June 2, 2022 when Village raised the Juneteenth flag at the municipal building.



The flag is rich in symbolism.

First, the Juneteenth flag uses the exact same colors as the United State's flag: red, white, and blue. Including the red, white, and blue symbolizes that the formerly enslaved and their descendants are free Americans, too.

Second, the Arc represents a "new horizon" meaning that fresh opportunities and promising futures exist for Black Americans.

Third, the Star is a nod not only to the Lone Star State of Texas, (where Juneteenth was first celebrated on June 19, 1865 when slavery was abolished), but also it stands for the freedom of every Black American in all 50 states.

Finally, the Burst, the outline surrounding the star reflects a nova — or new star— which represents a new beginning for all.

Broadview, the first municipality in Illinois to establish an official Juneteenth village holiday, has organized a three-day – June 17, 18, and 19 – official commemoration of Juneteenth – or Freedom Day. As part of the official recognition, Broadview will provide a paid-day off on Monday, June 20, to all village employees.

Broadview's Juneteenth celebration is inclusive. Our celebration embraces all races, ethnicities, religions, and nationalities. Most important, our Juneteeth rememberance provides the opportunity for all citizens to acknowledge a period in U.S. history that has influenced and shaped today's socieity while recognizing that work remains to be done.

It's an exciting time in the Village of Broadview.

Water Bill

• As of May 1, 2021, water rates have increased. All water bills are calculated in gallons for residential, commercial and industrial.

Vehicle Sticker

• Vehicle Stickers (2022-2023) were due by April 30, 2022. As of May 1, 2022, Vehicle Sticker prices have doubled.

Garbage Stickers

· Garbage Stickers are needed on all additional items. You can put out one item on your garbage pickup day. Any additional items without a sticker will not be picked up. (cost \$2)

Yard Stickers

• Yard Waste Stickers are needed for all yard waste bags (ie: grass & leaves). Make sure to place your yard waste bags out on your garbage pickup day only. (cost \$1.90)

• Pet Tags are available for purchase. All dog and cats must have current rabies shot numbers to receive a 2022 Pet Tag. (cost \$25)

The Village successfully weathered COVID-19 pandemic by carefully monitoring expenditures and supplemented decreased sales and other use tax revenues with various State and Federal Grants. As we look forward to the future, we are happy to announce the FY23 Budget was presented to the Village Board and residents, and it was approved at the April Board meeting.



Capital Improvement Projects

Broadview Public Works will be very busy this summer working on Capital Improvements throughout the Village.

Our biggest project will be the IEPA Watermain Improvements. These improvements will consist of installing a new 8" distribution watermain within the alleys north of Roosevelt between 25th and 18th Avenues and a new 16" transmission watermain within the alleys south of Roosevelt between 16th and 10th Avenues. These deteriorated asphalt alleys will be replaced with concrete after the completion of new water lines.



Additionally, water services on 25th Avenue between Roosevelt and Harvard will be transferred to a larger water main. All lead services found while completing these improvements will be replaced with new copper water services.


The Village also plans on rehabilitating 16th Street between 17th and 13th Avenues. This project will replace the existing asphalt roadways, portions of the existing concrete cub and sidewalk, and the asphalt parking areas along the Park District building. This project has an expedited schedule to ensure completion prior to the Village's Juneteenth celebration.

Late this summer, the Village will be moving forward with the 2022 CDBG Green Alleys. This project will be funded utilizing CDBG funds and will replace the north-south alleys between 17th and 16th Avenue (south of Fillmore) and 19th and 20th Avenue (South of Harvard). These alleys will be constructed of concrete, but will have sections of permeable brick pavers to reduce the amount of stormwater that will enter the Village's combined sewer system.

Finally, this summer the final completion of the Braga Drive Corridor Improvements with the wrapping up of intersection improvements at 17th Avenue.

In addition to these three construction projects, the Village will be investigating, designing, and seeking grant funding for a variety of other projects, including:

- Replacement of the 21st Street Bridge over Addison Creek
- Installation of a Multi-Use Trail on 25th Avenue from 14th Street to the Salt Creek trail at the Village's southern limits.
- Roosevelt Road Streetscape Improvements from 17th Avenue to eastern Village Limits




Nicor Gas is replacing high pressured gas mains and relocating services meters from inside homes/facilities to outside.

ComEd is Installing a 750KVA Transformer, Switchgear, Voltage Optimized Capacitor Bank, and 4500ft of conduit and cable to support the new assisted living building with 2 lines of service for redundancy. At the same time increasing the electrical capacity in the area for future potential growth needed in the area.

Village of Broadview Completed Our Village Wide Hydrant Flushing Program

On May 17, 2022 the Village of Broadview completed our village wide hydrant flushing program. The water department flushed (open and closed) 392 hydrants. During this process, the water department discovered 4 hydrants that were inoperable. All 4 hydrants have been replaced, the department also encountered minor maintenance issues from operating nuts needing adjustment or replacement and out flow caps needing to be lubricated.

Home Repair & Construction Advice

Common Home Repair Scams

The complaints that have been received by the Office of the Illinois Attorney General demonstrate that unscrupulous home repair contractors use



some common techniques to gain the confidence of homeowners. Unscrupulous contractors might tell you they have "leftovers" from a larger job and can do the repair work for you at a discount. They might attempt to frighten you by claiming that your house contains health hazards or code violations that must be fixed right away. They might claim to be a representative of your insurance company in an attempt to get you to agree to work. They might even say that your insurance policy will pay for the repairs. You might be offered a "free furnace cleaning" by a heating and cooling company as an excuse to sell you a new furnace you do not need.

HOMEOWNERS be aware when a home repair contractor:

- 1. Pressures you to sign papers today
- 2. Quotes a price and suggests that you don't need any other estimates
- 3. Tells you that full payment is required before starting the project
- 4. Comes to your home uninvited
- 5. Difficult to contact or can't be reached

Before You Start Your Project

Before you start your project, make sure to define the scope of the work that you are going to undertake. To define the scope of work, write down exactly what you want done in your



home, so that when you talk to a contractor, you will be able to focus on what you actually need and not be sold additional or unnecessary work. You should also write down the specifications for the job. The specifications should include such factors as the timeframe in which you want the work done, the type of materials you want the contractor to use, how you intend to pay for the job, and the payment schedule for the contractor, subcontractors, and suppliers. Your list of specifications can include anything about the project that is important to you and can serve as a reference for you when you interview contractors. If you think through the scope and specifications of the project ahead of time and put your expectations in writing, you can show a contractor what you need clearly and quickly.

DURING THE SUMMER SEASON, many of us think about remodeling or renovating our homes. The projects could be renovating the kitchen, upgrading the bathrooms, building a garage, or adding an addition onto the house. Before you jump on the remodeling/renovation bandwagon, here are a few things you need to know about choosing a contractor.

Ordinances

Please refer to the Village of Broadview Building Code(www.broadview-il.gov) for information regarding:

Contractor Registration | 9-2-8

Any contractor or subcontractor, whether an individual, sole proprietor, partnership or corporation, performing work in the village shall not commence work until the contractor or subcontractor has first applied for and received an annual certificate of registration.

Applications for the certificate of registration shall be submitted on forms supplied by the Building department.

All applications shall be accompanied by a registration fee in the amount of one hundred dollars (\$100.00), and by proof of a bond in the minimum sum of ten thousand dollars (\$10,000.00); provided however that the following contractor shall submit proof of a bond in the sums stated in section 3-1-6 of this code: house movers; sign erectors; building wreckers.

Upon receipt of the completed application, required fee and proof of bond, the Building Commissioner shall issue the certificate.

The annual certificate shall be valid for the current calendar year of January 1 to December 31. (Ord. 09-34, 8-3-2009)

Garage Sales | 4-12-1

Requires a permit - fee (\$10.00)

Garage sales shall be permitted for not more than 3 consecutive days between the hours of 9:00 a.m. – 6:00 p.m. of each day. Not more than 3 garage sales shall be conducted in a calendar year.

Noises

4-15-4: SPECIFIC LIMITATIONS:

For the purposes of this chapter, acts declared to be excessive, loud, raucous or unnecessary noises include, but are not limited to, the following:

A. Instruments And Sound Amplification Devices:
The playing, using, operating or permitting to be played, used or operated of any musical instrument or sound amplification device, or combination thereof, played or operated in such a manner as to disturb the peace, quiet comfort and repose of the neighboring inhabitants or at more volume than is necessary for the convenient hearing for the person or persons who are in the room, chamber, vehicle or outdoor area, within the Village limits, in which or where such instrument or sound amplification device is played, used or operated and who are voluntary listeners thereto. Home Repair & Construction Advice Continued

Finding a Contractor

- Get at least 3 written estimates from contractors who has come to your home to evaluate what needs to be done.
 Be sure the estimates are based on the same scope and specifications.
- Verify that the written contract is complete. It should consist
 of the work that will be done, the quality of the materials that
 will be used, warranties, timetables, the total
 price of the job,
 and the schedule of payments.
- Get recommendations and check references.
- 4. Make sure that all contractors are licensed, insured, bonded, and registered with the Village of Broadview.
- 5. Contact the Village of Broadview Building Department to check for codes, permits and inspection requirements.
- 6. Check the contractor's complaint records at the Illinois Attorney General's Office and the Better Business Bureau.
- 7. If the salesperson pressures you to sign before you've had a chance to read and understand all of the contract, DO NOT SIGN IT. Never rely on the salesperson to read or explain the contract to you. If you do not understand the contract, ask a trusted friend or lawyer to help you. Never sign a contract that has blank spaces. Finally, be sure to get a copy of everything you sign when you sign it.
- 8. Before you sign a contract, make sure it contains:
 - The contractor's full name, address, and telephone number;
 - A description of the work to be performed;
 - A detailed list of all materials, including product, color, model, size, and brand name;
 - The total cost for work performed, including charges for estimates and additional labor;
 - All oral promises made by the contractor in writing;
 - A description of how change orders will be handled;
 - Starting and estimated completion dates;
 - A schedule and method of payment, including down payment, subsequent payments, and final payment;
 - Written guarantees if the contractor warrants his or her work and product.



Remember, you have three business days to cancel any contract, if the sale is made and signed at your home. The contractor CANNOT take this right away from you by initiating work, selling your contract to a lender, or any other tactic. (See the Illinois Attorney General – Three Day Right To Cancel /Home Repair Contracts)

playing, use or operation of any such instrument or sound amplification device between the hours of ten o'clock (10:00) P.M. and eight o'clock (8:00) A.M. in such manner as to be plainly audible for a continuous period of one minute or more at a distance of seventy five feet (75') from the location of such instrument or sound amplification device shall be prima facie evidence of a violation of this section.

- B. Yelling, Shouting, And Similar Activities: Yelling, shouting, hooting, whistling or singing in the public parks, parkways and streets of the Village, particularly between the hours of ten o'clock (10:00) P.M. and eight o'clock (8:00) A.M., or at any other time or place so as to annoy or disturb the peace, quiet, comfort or repose of persons in any office, business establishment, dwelling or residence or of any person in the vicinity within the limits of the Village.
- C. Animals: The keeping of any animal within any yard, house, enclosure, garage or other place within the Village, which by frequent or long continued barking, howling, crying, singing or other noise shall disturb the peace, quiet, comfort or repose of persons in any neighboring dwelling or residence or of persons in the vicinity within the limits of the Village.
- D. Construction; Landscaping: The conduct of any outside construction, excavation, demolition, alteration or repair work, or landscaping activities other than between the hours of seven o'clock (7:00) A.M. and six o'clock (6:00) P.M. on week days, and between nine o'clock (9:00) A.M. and six o'clock (6:00) P.M. on weekends, except in case of urgent necessity in the interest of public health and safety, and then only with the written permission of the Building Director, which permit may be granted for a period not to exceed three (3) days or less while the emergency continues. The permit may be renewed for periods of three (3) days or less while the emergency continues. The Building Director should, in making a determination regarding such a permit request that the permittee will suffer loss or inconvenience in the absence of such a permit, that the public health and safety necessitate such work, and that the noise generated during the hours requested will not negatively impact or impair persons or businesses in the

Water Assessment Illinois EPA implemented

a Source Water Assessment Program (SWAP) to assist with watershed protection of public drinking water supplies. The SWAP inventories potential sources of contamination and determined the susceptibility of the source water to contamination.

Source Water Location

The City of Chicago utilizes Lake Michigan as its source water via two water treatment plants. The Jardine Water Purification Plant serves the northern areas of the City of Chicago and suburbs, while the South Water Purification Plant serves the southern portions of the City and suburbs. Lake Michigan is the only Great Lake that is entirely contained within the United States. It borders Illinois, Indiana, Michigan and Wisconsin, and is the second argest Great Lake by volume with 1,180 cubic miles of water and third largest by area.

Susceptibility to Contamination

The Illinois EPA considers all surface water sources of community water supply to be susceptible to potential pollution problems. The very nature of surface water allows contaminants to migrate into the intake with no protection only dilution. This is the reason for mandatory treatment of all surface water supplies in Illinois. Chicago's offshore intakes are located at a distance that shoreline impacts are not usually considered a factor on water quality. At certain times of the year, however, the potential for contamination exists due to wet-weather flows and river reversals. In addition, the placement of the crib structures may serve to attract waterfowl, gulls and tern that frequent the Great Lakes area, thereby concentrating fecal deposits at the intake and thus compromising the source water quality. Conversely, the shore intakes are highly susceptible to storm water runoff, marinas and shoreline point sources due to the influx of groundwater to the lake.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants that may be present in source water before treatment include:

- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- · <u>Pesticides and herbicides</u>, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the United States Environmental Protection Agency (USEPA) prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. TURBIDITY

Turbidity is a measure of the cloudiness of the water. We monitor it because it is a good indicator of water quality and the effectiveness of our filtration system and disinfectants.

UNREGULATED CONTAMINANTS:

A maximum contaminant level (MCL) for this contaminant has not been established by either state or federal regulations, nor has mandatory health effects language. The purpose for monitoring this contaminant is to assist USEPA in determining the occurrence of unregulated contaminants in drinking water, and whether future regulation is warranted.

FLUORIDE

Fluoride is added to the water supply to help promote strong teeth. The Illinois Department of Public Health recommends an optimal fluoride range of 0.9 mg/l to 1.2 mg/l.

SODIUM

There is not a state or federal MCL for sodium. Monitoring is required to provide information to consumers and health officials that are concerned about sodium intake due to dietary precautions. If you are on a sodium-restricted diet, you should consult a physician about this level of sodium in the water.




